- Krista Mount reviewed Fresno's LCAP data:
 - o Total Enrollment: 1,540 students

Demographics:

- 76.8% low-income
- 10.6% English Learners
- 0.3% homeless
- 0.03% foster youth
- 15% students with disabilities
- 79.4% unduplicated students requiring extra support
- Budget Allocation: Krista explained how funds are distributed across LCAP goals.

Discussion & Feedback

- o Mary Norris (High School Parent):
 - Stated that CAVA's actions are aligned with its goals and that improvements have been noticeable.
 - Suggested enhancing **peer-to-peer support** to help students and parents navigate the system more effectively.
- Krista Mount noted that under Career and Technical Education (CTE), four students earned dual enrollment credits last year. A second community college, Irvine Valley College, has been added alongside Norco College.
- Camey Valverde (TK-2 Parent):
 - Agreed that the proposed LCAP actions seem appropriate.
 - As a longtime CAVA parent, she has seen **significant improvements** in **differentiation**, particularly in small groups and partner teaching.
 - Noted that both her students receive special education services and that she has observed meaningful support.
- Krista Mount asked whether Camey had noticed differences from last year's LCAP.
 - Camey confirmed that instructional differentiation has improved.
- Moses Sami (8th Grade Student):
 - Expressed agreement with the LCAP details and believes the plan will be successful.

Additional Feedback & Responses

- Krista Mount highlighted that CAVA has significantly increased the number of clubs compared to last year.
- Leah Fellows noted an increase in in-person events, celebration activities, and student clubs, which were expanded based on parent and student feedback.
- Leah Fellows introduced the K12 Zone as a virtual environment for grades 3-5, middle school, and high school to promote student interaction. This was created in response to parent requests.
- Krista Mount mentioned that social-emotional learning (SEL) gaps were a concern raised by parents after COVID, and CAVA has been working to address these needs.
- Mary Norris (High School Parent):
 - Shared that her daughter, who has an IEP, has seen positive changes in evaluation and implementation processes, which have significantly benefited her.
- Camey Valverde (TK-2 Parent):
 - Suggested expanding the K12 Zone to include TK-2 students, as younger students also need a space to engage socially.
