San Diego Committee Review, Discussion, and Feedback

Participants: Ronald Dumale Jr. (8th Grade), Melissa Ramirez (Parent)

- **Leah Fellows** emphasized that EL, foster, and low-income students are receiving necessary support and reiterated the importance of ensuring all students succeed.
- She introduced the LCAP mid-year review to provide insight into CAVA's current progress.
- Ronald Dumale Jr. reviewed LCAP data from the website. Leah added the San Diego-specific infographic to the chat for reference.
- Krista Mount encouraged goal-by-goal discussions to provide focused feedback.
- Ronald Dumale Jr. shared his perspective:
 - He has had a great experience with CAVA and sees improvements in implemented initiatives.
 - As an honor student, he appreciates the safe and inclusive learning environment.
 - However, he noted that the K12 Zone administration rules seem too strict, sharing an example where he was flagged for using the word "eat."
 - Krista Mount thanked Ronald for his feedback, noting that the K12 Zone is a new initiative.
 - Leah Fellows, who oversees the K12 Zone, also expressed appreciation for Ronald's input and will review the concerns.
 - o **Ronald** thanked Leah for allowing him time to speak.
- **Krista Mount** reminded participants about next week's board meetings, where the LCAP will be presented, and encouraged attendance.
- **Leah Fellows** invited participants to the Winter Engagement meeting, where CAVA's performance will be compared to state data.
- **Leah Fellows** discussed CAVA's high student mobility, noting that many new students enter with academic deficits. She emphasized that data shows student performance improves with continued enrollment.
- **Leah Fellows** reminded parents about upcoming registration and encouraged continued support.
