Kacie asked a question about how to read data presented on the overview document. Krista explained using data about attendance and chronic absenteeism.

Kacie wanted to understand how committee members votes or input impact what is done on the LCAP. Committee gets to decide if interventions seem to be effective based on the data, bring questions about a specific intervention, or make suggestions.

Kacie asked about how or if the school is going by the current federal administration's mandates. Krista explained LCAP is state funded, so they are not worried about having to change language right now.

Kacie asked a question about what happens when intervention or plan is not working. Krista explains that the state gives three years to determine whether an intervention is effective. School does not have to wait three years to make a change.

Kacie asked about dual enrollment options. Career Technical Education and dual enrollment program has expanded, now has partnership with Norco City College and Irvine Valley College. Sonal offered that Irvine Valley College has human development & criminology program paths. Norco City College has courses that help meet general education requirements for UC credit.

Kacie asked whether there are any mentor programs between high school and middle school students. Sonal said she was not sure about middle school to high school mentorship, but there is a mentorship opportunity where 10th grade students mentor 9th grade students.

Kacie asked a question about clubs for students experiencing struggles with connecting with others. Discussion about clubs being on the same platform as school events, Sonal provided the link in the chat, and middle school students participating in the K12 Zone moderated by CAVA staff to help students with social struggles.

Sophia stated she and her friends would like to have more clubs for middle school students
